DECISION OF THE ENERGY CHARTER CONFERENCE

Subject: Report by the Chair of the Industry Advisory Panel

The Energy Charter Conference at its 31st Meeting held on 16-17 December 2020 **took note** of the Report by Chair of the Industry Advisory Panel as outlined in CC 703 and **approved** the IAP membership list attached thereto.

REPORT BY THE CHAIR OF THE INDUSTRY ADVISORY PANEL

The International Energy Charter Industry Advisory Panel (IAP) submits the Annual Communication on its work for the attention of the Energy Charter Conference.

The Energy Charter Conference is invited to take note of the Annual Communication of the IAP and approve the attached membership list.

Membership structure and new members

1. Currently, the IAP has 66 members (expected to reach 67 on 8 December 2020) from energy companies, international associations, intergovernmental institutions and individuals spanning 33 countries, which operate in fields such as exploration, production, generation, transmission, distribution, finance, equipment, services, technology and consultancy.
2. In 2020, the IAP received membership applications from two organisations, namely SolarPower Europe and COGEN Europe.
3. Over the past three years, the IAP has admitted seven new members, which confirms the continued value of the Panel as a well-established and respected platform for the exchange of knowledge and expertise on energy matters in the service of the entire Energy Charter constituency.
4. A full list of IAP members is provided in Annex 3.

Meetings

1. The IAP held one meeting in March 2020 and planned to hold another meeting in December.
2. The first meeting was held in Tirana, Albania, on 3 March 2020, hosted by the Trans Adriatic Pipeline. The meeting was devoted to issues related to the future role of energy infrastructure and strategies and market rules for a climate-neutral energy sector. Secretary General of the Energy Charter Secretariat, Amb. Dr. Urban Rusnák highlighted the importance of the commitment of the industry to the Energy Charter Process.
3. Mr. Rafael Cayuela Valencia, Corporate Chief Economist of Dow Chemical, was presented as the company's candidate for the position of the IAP Chair. Mr. Cayuela presented his vision for the development of the energy system in line with a net-zero carbon society.
4. The IAP will also hold a virtual meeting on 21 December 2020 hosted by SOCAR. At the meeting, the members are planning to welcome the new Chair and new members of the Panel and discuss IAP Work Programme 2021 and other internal items.
5. The message of Mr. Rafael Cayuela, Chair of the IAP, welcoming the third edition of the 2021 Energy Investment Risk Assessment (EIRA) report, was included in this flagship publication of the Energy Charter Secretariat.
6. The IAP representatives also attended the virtual launch of the #EIRA2020 which took place on 6 October 2020. Two IAP members, Mr. Henning Häder, Policy

Director at Eurelectric and Mr. Iván Pineda, Director of Public Affairs at WindEurope, made interventions at #EIRA2020 launch event. A significant number of IAP members joined the #EIRA2020 launch event as participants.

New IAP Chair

1. At the IAP meeting which took place on 4 June 2019 in Brussels, Mr. Howard Chase, Senior Director of Government Affairs for Dow Europe, Middle East, Africa and India, and Chair of the IAP since its inception in 2004, announced his intention to retire from this position. Mr. Rafael Cayuela Valencia was presented as candidate for the position of Chair of the IAP. There being no other candidates and following a written procedure, the IAP established Mr. Cayuela as new Chair of the IAP. Mr. Cayuela took up the post as of 24 March 2020.
2. All the IAP members extend their gratefulness to Mr. Howard Chase for his commitment to and leadership of the IAP since its inception. His invaluable contribution was crucial for building up a well-established and functioning Industry Advisory Panel.

Work Programme for 2021

1. The IAP members would welcome an opportunity to comment and provide further expert opinion further on the modernisation of the ECT if requested. The IAP remains ready to continue contributing to other initiatives of the Contracting Parties and promotion of the Energy Charter Treaty.
2. The Panel will work on the further engagement of organisations of sufficient standing across all aspects of the energy sector. . This will allow the Panel to sustain and continue to strengthen the quality and relevance of the consultative advice provided to the Energy Charter Conference by the Panel.
3. The members of the Panel will prepare a mid-term plan on the further development and functioning of the Panel. This strategic plan will set out specific objectives and milestones.
4. The IAP invites the Contracting Parties and Observer countries to continue to promote the IAP in their respective energy sectors and to suggest additions as appropriate to the membership of the Panel.

Annex 1

Joint Message of the Former and the Current Chairs of the International Energy Charter Industry Advisory Panel

I am deeply honoured to have chaired the International Energy Charter Industry Advisory Panel from its inception in 2004 until the meeting in Tirana, Albania, in March 2020. In my view, all of us who work in and are associated with the energy sector can be proud of our resilience and adaptability to constant change over these extraordinary times. The International Energy Charter has played an important part in sustaining international energy collaboration and investment through this period and the Industry Advisory Panel has provided considerable supporting expertise from a technical and business perspective. on The Energy Charter Treaty Modernisation Process

- *Investment is crucial to the global green energy transition. One of the prime purposes of the Energy Charter Treaty (ECT) is to support international investment flows in the energy sector through a rules-based approach and agreed procedures for dispute resolution. The International Energy Charter Industry Advisory Panel has for this reason given strong support over many years to the objectives of the ECT. We believe the Treaty will remain of equal or even greater relevance as investment accelerates in the green energy transition.*
- *In this context, we welcome the ongoing review of the ECT provisions and see room to clarify application of the Treaty in such areas as admissibility of claims, alternative dispute resolution procedures and pre-investment and energy transit provisions. Effective means for dispute resolution will remain fundamental to a rules-based approach to international energy investment and the successful operation of the Treaty.*
- *The Industry Advisory Panel is a voluntary consultative body to the Energy Charter Conference covering all aspects of energy supply, transportation,*

technology and use, with a strong focus on renewable energy, energy efficiency, new energy technologies and the green transition, and fully supports the ongoing process of stakeholder engagement and debate on the future of the Treaty.

Based on the needs of the Panel and the Energy Charter Conference, external experts will be invited to provide an opinion or to conduct research on specific topics. This expertise can be utilised for responding to a specific consultation, when necessary, and to spread knowledge on relevant topics.

Thank you for your trust, commitment and continuous support throughout all these years. Each and every member of the IAP has played a critical role in building and sustaining this important institution. We have all been striving, and all of us can be proud of the Panel's achievements. I am confident that your engagement and commitment will help to overcome existing and potential challenges and move forward towards the common goals.

I am looking forward to the upcoming activities of the Industry Advisory Panel. I hope that the next few years will be marked with new success stories and will result in considerable positive developments in the mentioned areas.

Annex 2

Terms of Reference (ToR) of the International Energy Charter Industry Advisory Panel (2020-2024)

1. The Industry Advisory Panel (IAP) was established by decision of the Energy Charter Conference (Conference) at its 14th Meeting on 15 June 2004 (document CCDEC 2004 6 IAP) and its mandate was renewed by subsequent Conference decisions in 2008, 2012, and 2015 (revised in 2018).
2. The IAP is a consultative body to the Conference and its Subsidiary Bodies, with the goal of putting forward the views of business on matters related to energy investment, dispute settlement, energy trade, transit, and energy efficiency. The IAP's mission is to forge closer ties between the Energy Charter Treaty (ECT) constituency and the industry, with a particular focus on the effective implementation of the ECT and principles of the International Energy Charter and the accession to the ECT.
3. The IAP is invited to promote the key principles of the International Energy Charter at relevant international conferences and events. To achieve the goal of providing advice and views of the industry, IAP Members (i) may regularly contribute to the activities, events (e.g. training programs, seminars) and publications (e.g. country reviews, reports, occasional papers) of the Energy Charter Secretariat (Secretariat); and (ii) sponsor additional activities, events, publications of the International Energy Charter, as well as assign energy industry experts to assist the Secretariat.
4. The composition of the IAP shall be representative of the energy industry of Members of the ECT and Observers to the Conference, both in terms of geography and sectors of economy. IAP Members shall be selected from energy companies, business associations and other organisations with substantial business interests in the energy sector, having their headquarters in the territories of Members of the ECT and Observers to the Conference. Interested representatives from the financial sector may be nominated. Members shall be at a senior level and actively involved in the decision-making process of their companies/organisations.
5. Interested candidates may submit their request for IAP membership to the IAP Chair. Members of the ECT may also propose candidates for IAP membership through the Secretary General of the Secretariat (Secretary General). It is at the discretion of the IAP Chair to initiate silent procedure or reach a decision in this respect at the subsequent IAP meeting.
6. Upon review of a membership request in the light of Paragraph 4 above, the IAP will submit a list of members by means of annual communication to the Conference. To the extent that the Conference cannot reach a consensus, the decision shall require a simple majority of the Contracting Parties of the ECT. Membership is renewed every year by submission of the list of members to the Conference.
7. The Conference or its Subsidiary Bodies may ask the IAP for advice. The IAP's advice will be presented to the Conference and/or its Subsidiary Bodies and annual Policy Conferences as appropriate and, as general rule, be considered in the context of the relevant Subsidiary Body before its submission to the Conference.

8. The IAP may request the Conference or its Subsidiary Bodies to consider issues falling within its mandate through a Formal Communication, at least on an annual basis. The Secretary General shall recommend that the Conference take account of such suggestions at a high political level. The Secretariat shall ensure that the Formal Communication is annexed or referred to in the final declaration of the Conference; it is proposed for implementation in the Programme of Work of the Secretariat and it is cited in the International Energy Charter meetings and activities.
9. The IAP may elect a Chair and other officers and organise its activities in accordance with these, as it deems appropriate. The IAP may establish a steering committee to assess the progress and the outcomes of the IAP work, to propose forward priorities and programme ideas and to assist logistics and administration of the IAP activities, when needed. The IAP may establish regional Chairs. The Secretariat shall assist the IAP in the organisation of its work. The Secretariat should prepare IAP meetings, draft IAP Formal Communications and statements; promote IAP membership and correspond with candidate members; and invite IAP members to contribute to its activities.
10. The Members of the IAP shall cover their own costs. The IAP may decide a membership fee. These contributions will solely be managed by the IAP and will be utilised exclusively for covering the expenses in relation to the IAP activities.
11. Representatives of the Industry Advisory Panel members consent to Secretariat's processing of their personal data in accordance with the Energy Charter Secretariat Manual on Data Protection. Contacts details of representatives of members of the IAP can be shared with the Chair and other IAP member representatives for purposes in relation to IAP activities. The Energy Charter Secretariat shall regularly make public the current membership list with the names of the representatives.
12. The Conference may periodically review the working methods of the IAP and its ToR in the light of the experience acquired through the years.
