The Energy Charter Treaty Forum is organized by the Arbitration Institute of the Stockholm Chamber of Commerce, in collaboration with the Energy Charter Secretariat, the International Center for Settlement of Investment Disputes (ICSID) and the Permanent Court of Arbitration (PCA).

The forum aims on illustrating the Energy Charter Treaty (ECT) as an international legal instrument to reduce barriers in the establishment of energy investments and as a risk reduction tool to the benefit of investors, financial institutions and host states. In addition, the forum aims on raising awareness on dispute settlement under the ECT, with a closer look on investment arbitration and mediation.
